We are continuing to operate to and within impacted areas as local conditions and restrictions allow. Due to the dynamic nature of the situation, quoted transit times, and pickup and delivery service availability may be subject to change without notice. Partial and temporary suspension of domestic and international pick-up and delivery services in India

Effective immediately, FedEx Express and TNT have temporarily and partially suspended domestic and international pick-up and delivery services to and from India until further notice. The service suspension is in response to the Government of India directives on the closure of offices, establishments and public transportation in key cities related to the containment of COVID-19.

Where possible, we will continue to move critical and life-saving medical shipments to and from India, including COVID-19 related items - testing kits, medicines, medical devices and bulk drugs/intermediaries for pharmaceuticals.

We will continue to monitor the situation closely in order to resume our normal operations as soon as the circumstances allow.

FedEx Express Money-Back Guarantee

The impact of COVID-19 is causing local, state, and national governments in Europe and around the world to issue work and travel restrictions on a daily basis, which are impacting our ability to meet our high standards of service.

As a result, we have made the decision to suspend our Money-Back Guarantee for all FedEx Express services, effective immediately until further notice.

FedEx Express is playing a crucial role in the global supply chain and connecting the world during this critical time, and we will continue operating as government restrictions and regulations allow.

No signature required for delivery

Please be assured that we are taking necessary precautions in affected areas as per the guidelines of local authorities. For the safety and wellbeing of our couriers and our customers, our couriers will now only seek a verbal confirmation of delivery. This means that your recipients will not be asked to sign for deliveries, until further notice.

If there is any conflict between the guidelines in this document and the instructions and requirements issued by local authorities or procedures in alignment with recommendations from local authorities, the instructions, requirements and recommendations issued by local authorities or in alignment with local authorities prevail.

Contingency plans have been put in place in order to minimize service delays and to ensure the continuity of operations to the best of our ability. Domestic and International pick-up and delivery services are suspended effective March 23rd, in the Orbassano, Alessandria, Bergamo and Brescia areas. Domestic pick-up for shipments above 68 kg and non-conveyable domestic shipments are limited across Italy. In the Como and Monza areas domestic pick-up services are suspended, while deliveries are partially performed. We anticipate service delays in the Bologna, Grosseto, Milan, Modena, Vicenza and Zibido areas. Due to the restrictions implemented by government authorities, until further notice we are not performing services in the municipalities of Fondi, Polla, Atena Lucana, Sala Consilina, Caggiano, Montebello Jonico, Saline Joniche, San Lucido, Belvedere Marittimo, Diamante, Grisolia, Medicina Ganzanigo. The export of Personal Protective Equipment (PPE such as FFP2 masks, goggles or visors, protective suits and gloves) is forbidden to be shipped out of Italy, without prior authorization from the Department of Civil Protection. Furthermore, following a Government decree that was issued on March 22nd, 2020, many industrial and commercial businesses (with the exception of a number of businesses identified as essential or strategic, including e.g. transport and courier) are being suspended until April 3rd, 2020; as a consequence, such businesses are no longer able to produce and ship goods; customers shipping from abroad to Italy are kindly invited to check the opening and availability of their recipients, in order to avoid delivery issues.
